If selected, ALL hunters must provide proof of a WV hunting license (out of state licensed applicants permitted) and a certificate for a hunter safety course at Check-in. ALL new hunters must attend one of the orientation sessions. All bow hunters must pass the annual proficiency shoot and attend an orientation/scouting session. Returning shotgun/muzzleloader hunters do not have to attend orientation, but stand locations and conditions may have changed so all are encouraged to make every effort to attend.

NOTICE: The Urban Bow hunts are under special permit, outside of the WV public hunt dates and do not count against a hunters tag limit.

Note: Special needs hunters may apply for **ALL** available dates.
